- 1. Organize Your Notes & Contacts
 - Review your notes and highlight key takeaways.
 - Sort business cards or digital contacts and add details about each person to remember the context of your conversation.
- 2. Send Follow-Up Messages
 - Personalized Emails Reach out to people you met, referencing specific discussions.
 - LinkedIn Connections Send connection requests with a short message about your conversation.
 - Thank-You Note If someone provided valuable insights or mentorship, a handwritten or thoughtful email can leave a lasting impression.
- 3. Share Insights & Takeaways
 - Write a blog post or social media update summarizing key lessons.
 - If relevant, share conference highlights with your team or community.
 - Engage in online discussions related to the event.

- 4. Take Action on What You Learned
 - Implement new strategies or ideas from the conference.
 - Follow up on potential business opportunities or collaborations.
 - Research additional resources or training based on what you discovered.
- 5. Stay Engaged with the Conference Community
 - Join post, events, webinars or discussion groups.
 - Subscribe to newsletters or follow speakers and organizations for ongoing updates.
 - Plan for the next VETS26 conference in NOLA, 1st-4th June!


